Climate & Energy

NCEL assisted lawmakers to advance a range of bold and equitable climate solutions in 2022. The Bold Decarbonization Working Group met regularly for learning opportunities on topics ranging from low-carbon transportation, green banks, and [Washington's Climate Commitment Act](#). NCEL hosted 22 climate-focused events, such as the first [New England Climate Convening](#) and [Southern Regional Environmental Legislators Conference](#). We expanded opportunities for legislators to take climate action through the power grid, including organizing lawmakers to speak out against climate-harming policies in [New England](#) and the [Mid-Atlantic](#). And more states focused on climate justice, such as [Maryland](#), which passed a landmark law setting one of the nation's most ambitious emission reduction goals while advancing environmental justice priorities.



Conservation

The conservation and revitalization of the nation's biodiversity garnered new attention from states in 2022. In May, [365 NCEL members](#) from 48 states and territories sent a letter to the Biden Administration requesting a coordinated federal strategy to address the rapid decline in wildlife and ecosystems. In addition to supporting lawmakers' work on biodiversity, habitat connectivity, pollinators, and other wildlife protections, NCEL continued its work to boost equitable nature access. Legislators from [28 states](#), including many members of NCEL's [Outdoor Working Group](#), championed bills to improve outdoor access and equity.



Environmental Health

Many states continued with focuses on reducing plastic pollution, cumulative pollution exposure, and the use of toxic chemicals in 2022. NCEL provided more shared learning opportunities its Plastic Pollution Working Group on a range of zero-waste solutions. NCEL members in [Colorado](#) sponsored landmark Extended Producer Responsibility (EPR) legislation, making it the third state to hold producers accountable for end-of-life management of plastic packaging. NCEL's Mississippi River Legislative Caucus expanded its ability to convene lawmakers around solutions to improve the health of the river, including an immersive [river tour](#) in June and the return of the annual [MRLC Forum](#) in September.



Ocean

To meet the increasing demand for ocean-based solutions, NCEL launched a new program dedicated solely to ocean policy topics such as the offshore energy transition, coastal resilience, and marine wildlife protection. Members of NCEL's Coastal Working Group, comprising 18 coastal states, continued to convene to learn from one another and present on the ocean-based solutions they're advancing, including at NCEL's legislator-led panel during [Capitol Hill Ocean Week](#).

One Big Thing: Federal Engagement

Throughout the year, NCEL facilitated collaboration between the state and federal levels to advance equitable environmental action. In response to historic federal investments from the [Bipartisan Infrastructure Law](#) and [Inflation Reduction Act](#), NCEL staff created briefing books and hosted events on the ways states can leverage these federal funds for environmental priorities. We connected state and federal officials by hosting events with the U.S. Department of Transportation and White House Council on Environmental Quality and sent a group of state legislators to the White House in December to discuss 2023 legislative priorities.

State Legislators from 35 States Convene in Denver to Discuss Environmental Policy

On July 29 and 30, over 100 state legislators from 35 states convened in Denver, Colorado for the in-person return of NCEL's [National Forum](#). The Forum provides state lawmakers the opportunity to collaborate on policy solutions related to climate, energy, conservation, and environmental health.

This year's National Forum was framed around NCEL's dedication to ensuring a healthy environment for all, opening with a session focused on centering health in environmental policy led by NCEL Program Managers. Other session topics included reversing the decline of biodiversity, expanding the U.S. offshore wind industry, creating renewable-friendly utility policy, protecting communities from toxic chemicals, and much more. Legislators heard from a range of environmental experts, as well as fellow lawmakers such as Rep. Joe Fitzgibbon, Rep. Debra Lekanoff, and Sen. Reuven Carlyle who were influential in securing the passage of [Washington's landmark cap-and-invest bill](#).

During the Forum weekend, NCEL partnered with REI's Denver Flagship Store to host our 25th Anniversary Celebration. Attendees enjoyed an evening of food, music, and conversation while hearing remarks on the history of NCEL and visiting with partner brands in the outdoor recreation industry. Here's to another 25 years of NCEL!

Global Issues, Local Solutions

At NCEL, it is our belief that addressing global environmental issues begins with strong local solutions. That is why we were thrilled to expand our international presence in 2022. NCEL sent delegations of state legislators to two United Nations Conferences to uplift the strong work of U.S. states and to learn from policymakers around the globe also working to tackle climate change and the biodiversity crisis.



COP27 United Nations Climate Change Conference Sharm El-Sheikh, Egypt | Nov. 2022

For the second year, NCEL sent a delegation of staff and state legislators to the [United Nations Climate Change Conference \(COP27\)](#) to exchange ideas with the world's climate leaders and showcase the leadership of U.S. states in addressing the climate crisis. While in Sharm El-Sheikh, Egypt, NCEL's delegation took part in six events, including NCEL's headline event on how states are addressing climate change and planning to implement new federal funding for environmental priorities. Other highlights included meeting with a delegation of Argentinian subnational leaders, a delegation of mayors and county officials from ICLEI, and top U.S. climate officials such as National Climate Advisor Ali Zaidi.



COP15 United Nations Biodiversity Conference Montreal, Canada | Dec. 2022

In December another delegation of NCEL staff and state legislators joined leaders from across the world at the [United Nations Biodiversity Conference \(COP15\)](#) in Montreal. Bringing the U.S. state perspective to international biodiversity talks is particularly important, as the U.S. is [one of the only nations](#) without a federal strategy to combat biodiversity loss and one of the two UN member states that has not ratified the Convention on Biological Diversity - the landmark international agreement to protect nature. While at COP15, NCEL's legislator delegation worked to show that despite federal inaction in the U.S., [states are leading the charge](#) on land, water, and wildlife protection.

Continued Growth

NCEL continues to grow its budget sustainably year-over-year. In 2022, NCEL reached our first \$2 million budget, while remaining in the top 20% of nonprofits for revenue. We intend to grow our budget and our impact even further in the coming years.

NCEL operates on an accrual accounting basis. As such, grants received in late 2021 to fund work throughout 2022 are not reflected in the revenue figure below. These funds, as planned, covered the difference between 2022 revenue and expenses.


