Dear Senate Majority Leader Schumer, House Speaker Pelosi, Senate Minority Leader McConnell, and House Minority Leader McCarthy:

We are 139 state legislators representing 19 coastal states, and we are writing to urge Congress to include \$10 billion in funding with no matching requirements for ocean and coastal habitat restoration in future stimulus or infrastructure initiatives. The COVID-19 pandemic has placed immense budget pressure on states, threatening cuts across several sectors. Federal financial support is needed now to combat the climate and economic crisis and move forward with critical coastal restoration projects.

About 40% of the population in the United States lives in coastal states, and our coastlines are a major economic contributor nationwide, providing \$9 trillion in goods and services, employing 57.5 million people, and paying \$3.6 trillion in wages. Simultaneously, coastal communities are directly impacted by the effects of climate change, including sea-level rise, increased storm events, loss of marine and coastal habitats, coastal pollution, and lost tourism. The COVID-19 pandemic has only worsened these effects.

We are encouraged by the federal government's renewed commitment to fighting climate change and Congress' commitment to providing financial support to communities across the country. Investment in coastal restoration projects would create jobs that directly stimulate the economy, restore coastal habitats, and protect coastal communities.

Healthy coastal habitats protect coastlines from storms and hurricanes and remove three to five times more carbon from the atmosphere per acre than land-based ecosystems.² Our states are home to salt marshes, seagrass meadows, mangrove forests, kelp forests, and coral reefs.³ These habitats protect our communities from the worst impact of hurricanes,⁴ and they serve as critical nursery grounds for species

in commercial and recreational fisheries.⁵ The 2020 hurricane season had the most storms and second-highest number of hurricanes on record,⁶ further intensifying the effects of degraded coastal habitats and the financial impacts of COVID-19. Investing in coastal restoration projects would not only help protect coastal habitats, it would boost the economy and protect the lives of communities that depend on the preservation of those habitats.

Coastal restoration projects would bring jobs to a broad range of the American workforce. These projects have the potential to create thousands of jobs requiring many types of labor, including construction workers, scientists, project managers, and engineers. In fact, a 2017 analysis by the National Oceanic and Atmospheric Administration (NOAA) found that stimulus-supported coastal restoration projects created over 2,200 jobs (approximately 15 jobs per million invested).

Our legislatures have set climate objectives, and our states have coastal restoration projects ready to proceed now. The need for federal funding to support coastal states is evident. In 2017, the National Coastal Resilience Fund received more than 167 proposals requesting over \$135 million, but it was only able to award funding to 19 projects totaling \$13.8 million.⁹

The COVID-19 pandemic has underscored the need for federal funding. Coastal communities in our states need support to recover from the devastation caused by this pandemic and climate change. Through this \$10 billion investment, Congress can help preserve critical habitats for fisheries, protect coastal communities from severe storm events, decrease greenhouse gases, and create thousands of jobs. We are encouraged by Congress' most recent actions and urge you to make this investment to help protect our coastlines. Thank you for your time and consideration.
