Dear Madam Secretary:

We are state legislators from around the nation dedicated to promoting a clean energy future to address the urgent issue of climate change. We appreciate your leadership in advancing HUD's climate goals and commitments. We write in support of the Public Health Law Center (PHLC) and other organization's petition for rulemaking to decarbonize and otherwise prepare HUD-assisted housing for climate change.

Together, residential and commercial buildings account for about 40% of U.S. energy use. Fossil fuels burned by appliances are a significant contributor to this energy use. Residential appliances paid for by HUD are responsible for approximately 13.6 million metric tons of carbon emissions annually.

Burning gas for cooking or heating is not just a threat to the climate, but also to human health. Gas-fueled appliances are a significant contributor to indoor air pollution. In fact, children in a home with a gas stove have a 24–42% increased risk of having asthma. A Lawrence Berkeley National Laboratory study found that cooking with gas exposes approximately 12 million Californians to pollutant levels that would exceed outdoor ambient air standards. Research suggests similar impacts nationwide.

What's more, this pollution tends to be concentrated in the homes of residents who are already facing disproportionate health and climate impacts. For instance, public housing residents are more likely to use gas stoves for supplemental heating, more likely to be in smaller living spaces which concentrates pollution levels, and more likely to live in areas with higher outdoor pollution levels.

The PHLC petition asks that HUD take commonsense steps to phase out gas-fired appliances in HUD-assisted housing, use HUD grant programs to support beneficial electrification, and require planning to prepare for and mitigate against climate-related health risks, among other proposals. We support the petition and urge HUD to grant it. We can think of few areas better to focus our decarbonization efforts than to benefit the residents of public housing.
